Your Choice Catering Supplies Ltd is committed to achieving Net Zero emissions by 2050.

Baseline Emissions Footprint

Baseline Year: **2022**

Baseline emissions are a record of the greenhouse gases produced prior to the introduction of any carbon reduction strategies. This is the first year our emissions have been measured.

Emissions Reduction Targets

To progress toward Net Zero, we have adopted the following carbon reduction targets:

- Reduce total emissions by **30% by 2030** (to **49.05 tCO₂e**).
- Transition to lower-emission company vehicles by 2035.
- Investigate and switch to **100% renewable electricity** by 2026.

We project that carbon emissions will decrease over the next five years through a combination of operational efficiencies, supplier engagement, and sustainable energy use.

Carbon Reduction Projects

Completed Initiatives

- Implemented fuel efficiency measures for company vehicles.
- Encouraged employee car-sharing to reduce commuting emissions.
- Improved warehouse energy efficiency by using LED lighting.

Future Initiatives

- Transition company fleet to electric or hybrid vehicles.
- Optimize delivery scheduling to reduce supplier emissions.
- Explore renewable energy options with E.ON for electricity supply.
- Improve waste management to minimize landfill impact.
